Please accept this letter and attached résumé as my application for appointment to the **Legislative- Citizen Commission on Minnesota Resources**. I believe my background and experience would be assets to the Commission.

My experience is deep and broad across many sectors. I was first elected to the Bemidji City Council in 2010 and have served as Mayor since January 2013. I will finish my fourth term and leave elected office at the end of 2020. As an elected official, I have learned the importance of being prepared, listening, asking good questions, building consensus, and making informed decisions.

I retired as NW Region Director for MN Department of Natural Resources in 2019 after serving three years as the regional planner for the DNR. Region 1 in NW Minnesota is a 23-county region that stretches from Lake of the Woods County in the north to Pope County in the south and includes the Red River Basin, agricultural, forested, prairie, and lakes regions. This experience gave me a broad understanding of our state's natural resource conservation efforts, economic benefits, and recreational importance. In my role as regional director, I was a member of the agency's leadership team and oversaw seven divisions — parks and trails, forestry, fish and wildlife, ecological water resources, lands and minerals, enforcement, and operations services. I worked together with a diverse group of partners including local governments, watershed districts, and advocacy groups for recreation, conservation, industry, and the environment.

My background also includes working as development specialist for Headwaters Regional Development Commission, a five-county regional planning organization and as assistant planner and community development director for the City of Bemidji. I was a Planner/Developer for Leech lake Band of Ojibwe for three years prior to my positions with MN DNR. As a planner, I have experience writing comprehensive plans, reviewing applications and site plans, and assessing plans and projects against criteria, rules, and ordinances. I am a member of American Institute of Certified Planners (AICP) and serve on the Board of American Planning Association, Minnesota Chapter.

In addition to my professional career, I've been a business owner and an adjunct professor at Bemidji State University where I taught courses in geography and political science.

I understand the grant-making process from both the application side and the review and recommendation side. I served 2013-2019 on the Greater Minnesota Regional Parks and Trails

Commission, which oversees the Parks and Trails Legacy funding for greater Minnesota. The GMRPTC works to recommend park and trail projects and build a recreational system for greater Minnesota that will serve our state for generations. During my tenure, we authored a system plan, developed a designation and funding application portal, and implemented an objective evaluation process that provides guidance and equity for recommendations.

As a planning professional, I have successfully authored state and local grant applications, securing funding in excess of \$6 million for public safety, telecommunications, infrastructure, park and trail development, public facilities, historic preservation, market research, comprehensive planning, downtown planning, and active living.

I'm a dedicated public servant. As I leave my elected role behind and look to the future, I continue to have the time, energy, and desire to serve the state of Minnesota. The state needs public servants who are dedicated to ethical, accountable, and transparent leadership. My service as an elected official and public employee speaks to that dedication. I look forward to continuing to help Minnesota be the best it can be. I hope you will agree that my background and experience would be assets to the Commission.
