Dear Mr. DeCramer:

Please accept this letter and the attached resume as my application for one of the two open at-large seats on the Minnesota Housing Finance Agency Board.

My experience with housing issues dates back to the beginning of my legal career at Mid-Minnesota Legal Aid, from 1990 to 1995, where I primarily represented tenants in housing cases. My work was mostly in North and South Minneapolis but I also spent a year on a Community Action for Suburban Hennepin (C.A.S.H.) blockfunding grant to represent tenants in the Hennepin County suburbs. I was familiar at that time with a wide range of subsidized housing programs, including public housing, several type of Section 8 programs, and Section 236 housing developments. I was also a young attorney on the team that brought the *Hollman v. Cisneros* public housing desegregation case in Minneapolis. Part of our preparation for that lawsuit was several months of educating ourselves on the history of housing segregation in the Twin Cities.

Following my years at Legal Aid, I worked at the Office of Lawyers Professional Responsibility, an agency of the Minnesota Supreme Court that investigates and prosecutes lawyers for ethical misconduct. From there I shifted to a leadership role in assisting the court-appointed Monitor in *Pigford v. Cisneros*, a nationwide class action brought by black farmers against the United States Department of Agriculture for racial discrimination in farm loan programs. A substantial focus of our work was considering the petitions of thousands of black farmers for review of their claims for

benefits under a consent decree. As the *Pigford* case began to wind up in 2006 and 2007, I decided to start a law practice narrowly focused on representing and advising lawyers in ethics matters.

I have substantial experience in board work. I have been on the board of Minnesota Lawyers Mutual, a mono-line lawyers liability insurer, for six years and have been chairing the Investment Committee for the past year. The company has an investment portfolio of over \$200M, mostly in municipal fixed-income investments. I have held several board leadership positions, including three years as president of the First Universalist Church Board of Trustees (six years total as a board member) and president of the Hennepin County Bar Association (2013-2014), with a total of seven years of service on the Finance Committee and Board of Directors. I have served on well over a dozen committees for various bar associations (Hennepin County and Minnesota State Bar Associations, American Bar Association, Association of Professional Responsibility Lawyers) and nonprofits. I believe I make a good board member because 1) I show up, 2) I read the financials and other materials; 3) I do not have a narrow personal agenda; and 4) I am not afraid to ask hard questions.

In recent years I have tried to rebalance my volunteer work from serving mostly on boards and committees to including direct service to low-income people by volunteering for five years at VITA tax clinics in North Minneapolis. I took a year off in 2022 because of the pandemic and plan to return this winter. VITA gives me an opportunity to interact with a diverse group of tax preparers (age, gender, race, nationality, work background) as well as a diverse clientele of people seeking tax filing assistance. VITA work also provides direct insight into how poor and low income families get along financially.

I find I am drawn to the MHFA Board because I see it as a way to get back to my "roots" in housing. Over the past year or two I have pulled back from most of my board and committee involvement (except for MLM) to make space for something new. I don't have a particular agenda to bring to the Board, except that there is a longtime crisis in housing in the country and in Minnesota that disproportionately impacts communities of color. I would like to have a small hand in addressing that.

I would look forward to discussing with you further how I might contribute to the MHFA's work. I appreciate your consideration of my application.
