-- President & CEO, Inter Faculty Organization, 2014-2018

As President, I represented the interests of the 4,000+ faculty at the 7 Minnesota state universities. I lead strategic planning for the union, which resulted in the first concrete articulation of the mission, vision, and guiding principles in the history of the organization. I provided oversight of 8 fulltime staff members, a \$2 million+ budget and \$3 million+ reserves. I had oversight of contract negotiations with the Minnesota State System and with the IFO staff association as well as oversight of contract enforcement, public and governmental affairs, and membership engagement.

As President of the Faculty Association of Minnesota State, Mankato, I represented the interests of the 700+ faculty, librarians, counselors and coaches. I served as the principle contact between administration and the faculty, the chair of the faculty executive committee, advocate for individual faculty in cases of dispute such as hostile workplace complaints and violations of Board Policy 1B.1. Perhaps the most difficult exercise I underwent occurred just prior to my stint as president when I served as vice-president and the university underwent retrenchment. As a faculty leader, the FA president and I, in collaboration with administration and other stakeholders, helped determine the metrics to be used to decide layoff of personnel across all divisions. I was the chair of the department of World Languages and Cultures at the same time and it happened that 1/3 of my colleagues in WLC were laid off. It was an experience that tested my leadership by fire.

As Chair, I represented faculty teaching a variety of languages (4 language programs with both undergraduate majors/minors and graduate MS degrees (Spanish and French)) to the College of Arts & Humanities and to the university at large. During my tenure as chair, I lead strategic planning for the department and the college and I lead concurrent enrollment initiatives. Under the leadership of Professor Kimberly Contag, I participated in the development of the first completely online Masters degree (MS) in Spanish in the nation; currently one of very few nationally. As chair, I provided mentorship, guidance, and evaluation of faculty both pre and post tenure in areas of teaching, research, professional development, contributions to student growth and development and service to the university and community.

As a member of the Board, I helped establish the mission, vision and values of the district and used data against which to measure our progress to our goals. As a board member, I helped provide oversight of control and accountability systems. I participated in the approval of expenditure and capital budgets. I was a member of the team that negotiated staff and transportation contracts for more than 8 years.

I was assigned some 40 students and worked with them over the course of the academic year (a dozen or so finished while I was there or shortly afterward) In addition, during the second semester, a faculty member had a medical issue and I was asked to teach courses in American Literature and American Culture.
