Previously appointed as Executive Director of the Minnesota Indian Affairs Council. Prior to this appointment, served as the Director of the Minnesota Department of Education - Office of Indian Education. Prior to serving in state government, held an executive appointment as Commissioner of Education for the Mille Lacs Band of Ojibwe. Worked formerly with American Indian communities, schools, elected officials, and tribal governments through federally-funded grant initiatives at the University of Minnesota, Institute on Community Integration. Over twenty-two years' experience working directly with state and federal officials and agencies, tribal elected leaders, community-serving organizations, students, youth, and families.
