**FIRST READING OF HOUSE BILLS**

The following bill was read the first time and referred to the committee indicated.

**H.F. No. 264:** A bill for an act relating to energy; correcting names of legislative committees represented by certain members of legislative electric energy task force; amending Minnesota Statutes 2000, section 216C.051, subdivision 2.

Referred to the Committee on Telecommunications, Energy and Utilities.

**REPORTS OF COMMITTEES**

Senator Hottinger moved that the Committee Reports at the Desk be now adopted. The motion prevailed.

**Senator Ranum from the Committee on Crime Prevention, to which was referred**

**S.F. No. 287:** A bill for an act relating to crime prevention; clarifying and modifying the crime of nonsupport of a spouse or child; amending Minnesota Statutes 2000, section 609.375, subdivisions 1, 2, 2a, and by adding a subdivision.

Reports the same back with the recommendation that the bill be amended as follows:

Page 2, line 14, delete everything after "that"

Page 2, delete lines 15 to 18 and insert "the omission and failure to provide care and support were with lawful excuse."

And when so amended the bill do pass and be re-referred to the Committee on Judiciary. Amendments adopted. Report adopted.

**Senator Sams from the Committee on Health and Family Security, to which was referred**

**S.F. No. 256:** A bill for an act relating to health occupations; establishing the council of health boards; amending Minnesota Statutes 2000, sections 214.001, by adding a subdivision; and 214.01, by adding a subdivision.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, after line 12, insert:

"Sec. 2. Minnesota Statutes 2000, section 214.002, subdivision 1, is amended to read:

Subdivision 1. [WRITTEN REPORT.] Within 15 days of the introduction of a bill proposing new or expanded regulation of an occupation, the proponents of the new or expanded regulation shall submit a written report to the chair of the standing committee in each house of the legislature to which the bill was referred and to the council of health boards setting out the information required by this section. If a committee chair requests that the report be submitted earlier, but no fewer than five days from introduction of the bill, the proponents shall comply with the request."

Page 1, line 13, delete "2" and insert "3"

Page 1, after line 17, insert:

"Sec. 4. [214.025] [COUNCIL OF HEALTH BOARDS.]

The health-related licensing boards may establish a council of health boards consisting of representatives of the health-related licensing boards and the emergency medical services regulatory board. Members shall serve on a voluntary basis without compensation or

reimbursement of expenses. When reviewing legislation or legislative proposals relating to the regulation of health occupations, the council shall include the commissioner of health or a designee."

Amend the title as follows:

Page 1, line 4, before "and" insert "214.002, subdivision 1;"

Page 1, line 5, before the period, insert "; proposing coding for new law in Minnesota Statutes, chapter 214"

And when so amended the bill do pass and be re-referred to the Committee on State and Local Government Operations. Amendments adopted. Report adopted.

**Senator Sams from the Committee on Health and Family Security, to which was referred**

**S.F. No. 249:** A bill for an act relating to state government; health and human services; repealing obsolete rules; repealing Minnesota Rules, parts 2500.2050; 2500.2060; 2500.2070; 4620.1800; 4635.0100; 4635.0200; and 4761.1230.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, after line 7, insert:

"Section 1. Minnesota Statutes 2000, section 144.99, subdivision 1, is amended to read:

Subdivision 1. [REMEDIES AVAILABLE.] The provisions of chapters 103I and 157 and sections 115.71 to 115.77; 144.12, subdivision 1, paragraphs (1), (2), (5), (6), (10), (12), (13), (14), and (15); 144.1201 to 144.1204; 144.121; 144.1222; 144.35; 144.381 to 144.385; 144.411 to 144.417; 144.495; 144.71 to 144.74; 144.9501 to 144.9509; 144.992; 326.37 to 326.45; 326.57 to 326.785; 327.10 to 327.131; and 327.14 to 327.28 and all rules, orders, stipulation agreements, settlements, compliance agreements, licenses, registrations, certificates, and permits adopted or issued by the department or under any other law now in force or later enacted for the preservation of public health may, in addition to provisions in other statutes, be enforced under this section."

Page 1, after line 12, insert:

"Sec. 3. [REPEALER.]

Minnesota Statutes 2000, section 144.495, is repealed."

Re-number the sections in sequence

Amend the title as follows:

Page 1, line 3, after "rules;" insert "amending Minnesota Statutes 2000, section 144.99, subdivision 1;" and after the second "repealing" insert "Minnesota Statutes 2000, section 144.495;"

And when so amended the bill do pass. Amendments adopted. Report adopted.

**Senator Sams from the Committee on Health and Family Security, to which was re-referred**

**S.F. No. 232:** A bill for an act relating to local government; authorizing special taxing districts for emergency medical services; authorizing property tax levies; adding to the list of special taxing districts; amending Minnesota Statutes 2000, section 275.066; proposing coding for new law as Minnesota Statutes, chapter 144F.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Taxes. Report adopted.

**S.F. **S.F. No. 263:** A bill for an act relating to metropolitan agricultural preserves; permitting an exception to the maximum residential density requirement of long-term agricultural land under certain specific conditions; amending Minnesota Statutes 2000, section 473H.03, by adding a subdivision.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. [CITY OF AFTON; EARLY TERMINATION OF AGRICULTURAL PRESERVE.]

Notwithstanding Minnesota Statutes, sections 473H.08 and 473H.09, providing for the duration and early termination of a metropolitan agricultural preserve, the city of Afton may initiate expiration of a parcel of land from an agricultural preserve for which the landowner has previously initiated expiration under Minnesota Statutes, section 473H.08, subdivision 2, located in the city of Afton, Washington county, and described as:

the Northeast Quarter of the Northeast Quarter of Section 29, Township 28 North, Range 20 West of the Fourth Principal Meridian.

The effective date of the expiration may be on any date after the effective date of this section as determined by the Afton city council, once the council has otherwise complied with the procedural requirements of Minnesota Statutes, sections 473H.04 and 473H.08. All benefits accruing to the parcel as an agricultural preserve, including benefits relating to the valuation and assessment of the parcel for ad valorem property taxes under Minnesota Statutes, chapter 273, and section 473H.10, shall cease on the date of expiration.

Sec. 2. [EFFECTIVE DATE.]

Section 1 is effective without local approval on the day following final enactment."

Delete the title and insert:

"A bill for an act relating to the city of Afton; authorizing the city to provide for expiration of a certain parcel of land from a metropolitan agricultural preserve at an earlier date."

And when so amended the bill be re-referred to the Committee on Taxes without recommendation. Amendments adopted. Report adopted.

**Senator Vickerman from the Committee on State and Local Government Operations, to which was referred**

**S.F. No. 405:** A bill for an act relating to historic sites; designating Little Elk Heritage Preserve as a historic preserve; appropriating money; amending Minnesota Statutes 2000, section 138.664, by adding a subdivision.

Reports the same back with the recommendation that the bill be amended as follows:

Page 2, line 4, after the period, insert "The state register of historic places listing includes those portions of the preserve that contain significant archaeological or historic resources."

Amend the title as follows:

Page 1, line 3, delete "preserve" and insert "place"

[SNOWPLOWS.] Vehicles that have a gross weight exceeding 26,000 pounds; that are owned by, or under contract with, a town to provide snow removal services; that are operated by drivers employed seasonally or temporarily for that purpose; and that are used exclusively as snowplows, are exempt from the provisions of this chapter."

Delete the title and insert:

"A bill for an act relating to motor vehicles; exempting certain snowplows from registration taxes; amending Minnesota Statutes 2000, section 168.012, by adding a subdivision."

And when so amended the bill do pass and be re-referred to the Committee on Finance. Amendments adopted. Report adopted.

**Senator Kelly, R.C. from the Committee on Transportation, to which was referred**

**S.F. No. 174:** A bill for an act relating to traffic regulations; allowing gross weight seasonal increase for transporting carrots; amending Minnesota Statutes 2000, section 169.825, subdivision 11.

**Senate Resolution No. 57:** A Senate resolution congratulating Minnesota's charter schools.

WHEREAS, ten years ago, Minnesota became the first state in the nation to enact legislation allowing the creation of charter schools, which have prompted innovation and new choices in public education and new opportunities for students; and

WHEREAS, under the law, the role of public school boards was transformed from merely delivering public education services to purchasing services, setting goals, measuring performance, and enforcing accountability; and

WHEREAS, charter schools are independent public schools where teachers and parents have autonomy regarding budget, staffing, curriculum, and teaching methods; and where public school funding follows the student to the charter school; and

WHEREAS, City Academy, the nation's first operating charter school, opened in St. Paul in September 1992; and

WHEREAS, since the Minnesota Legislature passed the first charter school law, 36 states and the District of Columbia have passed laws authorizing charter schools, and some 1,700 charter schools serve about 350,000 students around the nation; and

WHEREAS, charter school successes have included better student performance for students with special needs, as well as high levels of satisfaction among students, teachers, and parents; and

WHEREAS, Minnesota's charter school law has taken a balanced approach by encouraging growth of charter schools while holding them accountable; and

WHEREAS, in October 2000, the Minnesota charter school law was named a winner in the Innovations in American Government Awards Program, of the Kennedy School of Government at Harvard University, and was among only ten recipients of one of the nation's most prestigious public service awards; and

WHEREAS, the award also includes a \$100,000 grant that will be used to increase public awareness of charter schools and to encourage replication by other states; NOW, THEREFORE,

BE IT RESOLVED by the Senate of the State of Minnesota that it extends recognition and gratitude to the many persons who have contributed to the birth, growth, and success of charter schools:

The members of the 1991 Minnesota Legislature, especially the chief authors of 1991 S.F. 630

and H.F. 773, Senator Ember Reichgott Junge and Representative Becky Kelso and co-author Senator Gen Olson;

The governors who gave their steadfast support to the charter school initiative, Governor Rudy Perpich and Governor Arne Carlson;

The legislative staff members and department personnel who labored long to work out the details of the legislation;

The sponsors and school districts who have had the courage and commitment to back charter schools;

The charter school educators, administrators, and parents whose valuable, innovative, and committed work has turned a legislative hope into reality; and

The many organizations throughout the country who work toward education reform to ensure the best possible education for all children.
