REPORTS OF COMMITTEES

Senator Gazelka moved that the Committee Reports at the Desk be now adopted. The motion prevailed.

Senator Housley from the Committee on Aging and Long-term Care Policy, to which was referred

S.F. No. 395: A bill for an act relating to human services; modifying the operating payment rate for certain nonprofit nursing facilities in border cities; amending Minnesota Statutes 2016, section 256R.53, subdivision 2.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 9, reinstate the stricken "city" and delete "cities" and delete "and" and insert "or"

Page 1, line 13, strike everything after "determined"

Page 1, line 14, strike "as determined"

Page 1, line 16, strike everything after the period

Page 1, strike line 17

Page 1, line 18, strike everything before the period and insert "The commissioner shall make the comparison required in this subdivision on November 1 of each year and shall apply it to the rates to be effective on the following January 1. If the adjustments under this subdivision result in a rate that exceeds the total care-related payment limits in section 256R.23, subdivision 5, and whose costs exceed the other operating payment rate in section 256R.24, subdivision 3, in a given rate year, the facility's rate shall not be subject to the limits in section 256R.23, subdivision 5, and shall not be limited to the rate established in section 256R.24, subdivision 3, for that rate year"

And when so amended the bill do pass and be re-referred to the Committee on Human Services Reform Finance and Policy. Amendments adopted. Report adopted.

Senator Housley from the Committee on Aging and Long-term Care Policy, to which was referred

S.F. No. 120: A bill for an act relating to human services; extending the Alzheimer's disease working group; proposing coding for new law in Minnesota Statutes, chapter 256.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. [256.9775] ALZHEIMER'S DISEASE WORKING GROUP.

Subdivision 1. Establishment. The Minnesota Board on Aging shall establish the Alzheimer's disease working group to advise and make recommendations to the governor and the legislature

concerning the needs of individuals diagnosed with Alzheimer's disease, services available to meet these needs, and the capacity of the state and current providers to meet these needs and future needs.

Subd. 2. **Members.** (a) The Minnesota Board on Aging must appoint no more than 20 members to the working group, including, but not limited to:

(1) a caregiver of a person who has been diagnosed with Alzheimer's disease;

(2) a person who has been diagnosed with Alzheimer's disease;

(3) two representatives from the nursing facility or senior housing profession;

(4) a representative of the home care or adult day services profession;

(5) two representatives of the medical care provider community, one of whom serves a diverse or underserved community;

(6) a psychologist who specializes in dementia care;

(7) an Alzheimer's researcher;

(8) a representative of the Alzheimer's Association;

(9) two members from community-based organizations serving one or more diverse or underserved communities;

(10) the commissioner of human services or a designee;

(11) the commissioner of health or a designee;

(12) the ombudsman for long-term care or a designee; and

(13) at least two public members named by the governor.

(b) The appointing authorities under this subdivision must complete their appointments no later than July 15, 2017.

(c) To the extent practicable, the membership of the working group must reflect the diversity in Minnesota, and must include representatives from rural and metropolitan areas and representatives of different ethnicities, races, genders, ages, cultural groups, and abilities.

Subd. 3. **Duties; recommendations.** The Alzheimer's disease working group must review and revise the 2011 report, Preparing Minnesota for Alzheimer's: the Budgetary, Social and Personal Impacts. The working group shall consider and make recommendations and findings on the following issues:

(1) cultural competency and responsiveness to reduce health disparities and improve access to high-quality dementia care;

(2) trends and disparities in the state's Alzheimer's population;

(3) public awareness, knowledge, and attitudes, including knowledge gaps, stigma, availability of information, and supportive community environments;

(4) risk reduction, including health education and health promotion on risk factors, safety, and potentially avoidable hospitalizations;

(5) diagnosis and treatment, including early detection, access to diagnosis, quality of dementia care, and cost of treatment;

(6) professional education and training, including geriatric education for licensed health care professionals and dementia-specific training for direct care workers, first responders, and other professionals in communities;

(7) caregivers, including contributions, supports, family caregiver education, and unmet needs;

(8) home and community-based care versus residential care, including research efforts;

(9) home and community-based services, including cost to families, access to affordable, quality services, service planning and delivery, and workforce development;

(10) residential services, including cost to families as well as regulation and licensing gaps;

(11) financing long-term care, including Medicare, Medicaid, and long-term care insurance;
and

(12) research and data collection, including public health surveillance.

Subd. 4. **Term.** Members of the working group shall serve for four years and may be reappointed. Members shall serve until their successors have been appointed.

Subd. 5. **Meetings.** (a) The board must select a designee to convene the first meeting of the working group no later than July 15, 2017. Meetings of the working group must be open to the public, and to the extent practicable, technological means, such as Web casts, shall be used to reach the greatest number of people throughout the state. The members of the working group shall select a chair from their membership at the first meeting.

(b) The working group shall meet at least once every four years.

Subd. 6. **No compensation.** Members of the working group serve without compensation, except for reimbursement from the board for allowed and necessary expenses incurred in the performance of the member's working group duties.

Subd. 7. **Report.** The Board on Aging must submit a report providing the findings and recommendations of the working group, including any draft legislation necessary to implement the recommendations, to the governor and chairs and ranking minority members of the legislative committees with jurisdiction over health care no later than January 15, 2018, and must provide an updated report every four years thereafter.

Subd. 8. **Sunset.** The working group shall expire on January 15, 2030."

Amend the title numbers accordingly

Senator Kiffmeyer from the Committee on State Government Finance and Policy and Elections, to which was re-referred

S.F. No. 112: A bill for an act relating to health; creating the Palliative Care Advisory Council; proposing coding for new law in Minnesota Statutes, chapter 144.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. [144.059] PALLIATIVE CARE ADVISORY COUNCIL.

Subdivision 1. **Membership.** The Palliative Care Advisory Council shall consist of 18 public members and four members of the legislature.

Subd. 2. **Public members.** (a) The commissioner shall appoint, in the manner provided in section 15.0597, 18 public members, including the following:

(1) two physicians, of which one is certified by the American Board of Hospice and Palliative Medicine;

(2) two registered nurses or advanced practice registered nurses, of which one is certified by the National Board for Certification of Hospice and Palliative Nurses;

(3) one care coordinator experienced in working with people with serious or chronic illness and their families;

(4) one spiritual counselor experienced in working with people with serious or chronic illness and their families;

(5) three licensed health professionals, such as complementary and alternative health care practitioners, dieticians or nutritionists, pharmacists, or physical therapists, who are neither physicians nor nurses, but who have experience as members of a palliative care interdisciplinary team working with people with serious or chronic illness and their families;

(6) one licensed social worker experienced in working with people with serious or chronic illness and their families;

(7) four patients or personal caregivers experienced with serious or chronic illness;

(8) one representative of a health plan company;

(9) one physician assistant that is a member of the American Academy of Hospice and Palliative Medicine; and

(10) two members from any of the categories described in clauses (1) to (9).

(b) The commissioner must include, where possible, representation that is racially, culturally, linguistically, geographically, and economically diverse.

(c) The council must include at least six members who reside outside Anoka, Carver, Chisago, Dakota, Hennepin, Isanti, Mille Lacs, Ramsey, Scott, Sherburne, Sibley, Stearns, Washington, or Wright Counties.

(d) To the extent possible, council membership must include persons who have experience in palliative care research, palliative care instruction in a medical or nursing school setting, palliative care services for veterans as a provider or recipient, or pediatric care.

(e) Council membership must include health professionals who have palliative care work experience or expertise in palliative care delivery models in a variety of inpatient, outpatient, and community settings, including acute care, long-term care, or hospice, with a variety of populations, including pediatric, youth, and adult patients.

Subd. 3. **Legislative members.** The majority leader in the senate shall appoint one member of the senate, the minority leader in the senate shall appoint one member of the senate, the speaker of the house shall appoint one member of the house of representatives, and the minority leader in the house of representatives shall appoint one member of the house of representatives.

Subd. 4. **Term.** Members of the council shall serve for a term of three years and may be reappointed. Members shall serve until their successors have been appointed.

Subd. 5. **Administration.** The commissioner or the commissioner's designee shall provide meeting space and administrative services for the council.

Subd. 6. **Chairs.** At the council's first meeting, and biannually thereafter, the members shall elect a chair and a vice-chair whose duties shall be established by the council.

Subd. 7. **Meeting.** The council shall meet at least twice yearly.

Subd. 8. **No compensation.** Public members of the council serve without compensation.

Subd. 9. **Duties.** (a) The council shall consult with and advise the commissioner on matters related to the establishment, maintenance, operation, and outcomes evaluation of palliative care initiatives in the state.

(b) By February 15 of each year, the council shall submit to the chairs and ranking minority members of the committees of the senate and the house of representatives with primary jurisdiction over health care a report containing:

(1) the advisory committee's assessment of the availability of palliative care in the state;

(2) the advisory committee's analysis of barriers to greater access to palliative care; and

(3) recommendations for legislative action, with draft legislation to implement the recommendations.

(c) The Department of Health shall publish the report each year on the department's Web site.

Subd. 10. **Open meetings.** The council is subject to the requirements of chapter 13D.

Subd. 11. **Sunset.** The council shall sunset January 1, 2025.

Sec. 2. **PALLIATIVE CARE ADVISORY COUNCIL.**

The appointing authorities shall appoint the first members of the Palliative Care Advisory Council under Minnesota Statutes, section 144.059, by October 1, 2017. The commissioner of health shall convene the first meeting by November 15, 2017, and the commissioner or the commissioner's designee shall act as chair until the council elects a chair at its first meeting.

Sec. 3. **EFFECTIVE DATE.**

Sections 1 and 2 are effective the day following final enactment."
