**STATE OF MINNESOTA
PROCLAMATION FOR SPECIAL SESSION 2020**

WHEREAS: The Ninety-First Legislature adjourned its session on May 17, 2020; and

WHEREAS: Our State faces historic challenges; and

WHEREAS: The tragic and unnecessary death of George Floyd has laid bare the need for systemic police accountability and reform in Minnesota; and

WHEREAS: The COVID-19 pandemic continues to threaten Minnesotans and burden our State's resources; and

WHEREAS: Both the COVID-19 pandemic and recent civil unrest have caused economic damage to local communities, leaving Minnesota in need of a stronger and more equitable economy; and

WHEREAS: The Minnesota Constitution allows the Governor to call a special session of the Legislature on extraordinary occasions; and

WHEREAS: Minnesota Statutes 2019, section 12.31, subdivision 2(b), provides that, if the Governor determines a need to extend a peacetime emergency beyond 30 days and the Legislature is not sitting in session, the Governor must issue a call immediately convening both houses of the Legislature; and

WHEREAS: An extraordinary occasion, as envisioned by the Minnesota Constitution, has arisen, and it is necessary to extend the COVID-19 Peacetime Emergency originally declared on March 13, 2020.

NOW, THEREFORE, I, Tim Walz, Governor of Minnesota, by the authority vested in me by Article IV, Section 12 of the Minnesota Constitution and Sections 4.03 and 12.31 of the Minnesota Statutes, summon the members of the Legislature to convene in Special Session on Friday, June 12, 2020 at 12:00 p.m. at the State Capitol in Saint Paul, Minnesota.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the Great Seal of the State of Minnesota to be affixed at the State Capitol on Wednesday, June 10, 2020.

MOTIONS AND RESOLUTIONS

Senators Gazelka and Kent introduced --

Senate Resolution No. 1: A Senate resolution relating to organization and operation of the Senate during the Special Session.

BE IT RESOLVED by the Senate of the State of Minnesota:

The Senate is organized under Minnesota Statutes, sections 3.073 and 3.103.

The Temporary Rules of the Senate for the 91st Legislature are the Rules for the Special Session, except that Rules 3.6, 5, and 9 are not operative other than as provided in this resolution.

The Committee on Rules and Administration and the Committee on Finance are established in the same manner and with the same powers as in the 91st Legislature.

With respect to Rule 30, Reconsideration, a notice of intention to move for reconsideration is not in order, but a motion to reconsider may be made, and when made has priority over other business except a motion to adjourn.

Senator Gazelka moved the adoption of the foregoing resolution.

The question was taken on the adoption of the resolution.

The motion prevailed. So the resolution was adopted.

Senators Gazelka and Kent introduced --

Senate Resolution No. 2: A Senate resolution relating to notifying the House of Representatives and the Governor that the Senate is organized.

BE IT RESOLVED by the Senate of the State of Minnesota:

The Secretary of the Senate shall notify the House of Representatives and the Governor that the Senate is now duly organized under the Minnesota Constitution and Minnesota Statutes.

Senator Gazelka moved the adoption of the foregoing resolution. The motion prevailed. So the resolution was adopted.

Senator Gazelka introduced --

Senate Concurrent Resolution No. 1: A Senate concurrent resolution relating to Minnesota's peacetime emergency; terminating the peacetime emergency pursuant to the authority granted under Minnesota Statutes, section 12.31, subdivision 2, paragraph (b).

WHEREAS, Governor Walz signed Executive Order 20-01, a declaration of a peacetime emergency on March 13, 2020; and

WHEREAS, the Executive Council of the State extended that peacetime emergency for up to 30 days, on March 16, 2020; and

WHEREAS, on May 13, 2020, by Executive Order 20-55, Governor Walz extended the peacetime public emergency declared under Executive Order 20-01 and extended in Executive Order 20-35, until June 12, 2020; NOW, THEREFORE,

BE IT RESOLVED by the Senate of the State of Minnesota, the House of Representatives concurring: that the legislature exercises its authority under Minnesota Statutes, section 12.31, subdivision 2, paragraph (b), terminating the peacetime emergency declared under Executive Order 20-01 the day following the concurrence by the House of Representatives with this resolution.

BE IT FURTHER RESOLVED that the Secretary of the Senate is directed to prepare an enrolled copy of this resolution, to be authenticated by his signature and those of the Speaker of the House of Representatives, the Chair of the Senate Rules and Administration Committee, and the Chief Clerk of the House of Representatives, and transmit it to the Governor of the State of Minnesota.

Senator Gazelka moved the adoption of the foregoing resolution.

Senator Little moved to amend Senate Concurrent Resolution No. 1 as follows:

Page 1, line 11, delete "NOW, THEREFORE,"

Page 1, after line 11, insert:

"WHEREAS, 1. Pursuant to Minnesota Statutes 2019, section 182.654, subdivision 9, and Code of Federal Regulations, title 29, section 1977.9(c), employers must not discriminate or retaliate in any way against a worker communicating orally or in writing with management personnel about

occupational safety or health matters related to COVID19, including asking questions or expressing concerns;

2. Employers must not discriminate or retaliate in any way against any worker for wearing gloves, a cloth face covering, eye protection, or other protective gear which the worker has personally procured and reasonably believes will protect them, their coworkers or the public against COVID-19 in the course of their work, provided that the protective gear which the worker has personally procured does not violate industry standards or existing employer policies related to health, safety, or decency. Employers may require use of employer-provided protective gear that meets or exceeds protective gear procured by employees;

3. Pursuant to Minnesota Statutes 2019, section 182.654, subdivision 11, workers have the right to refuse to work under conditions that they, in good faith, reasonably believe present an imminent danger of death or serious physical harm. This includes a reasonable belief that they have been assigned to work in an unsafe or unhealthful manner with an infectious agent such as COVID-19. Employers must not discriminate or retaliate in any way against a worker for the worker's good faith refusal to perform assigned tasks if the worker has asked the employer to correct the hazardous conditions but they remain uncorrected. These situations should be immediately reported to the Minnesota Department of Labor and Industry ("DLI");

4. Pursuant to Minnesota Statutes 2019, section 182.654, subdivisions 8 and 9, workers and authorized representatives of workers have the right to request that DLI conduct an inspection of their workplace if they believe that a violation of a safety or health standard that threatens physical harm exists or that an imminent danger exists. Employers must not discriminate or retaliate in any way against a worker because such worker has requested an inspection or exercised any other right under Minnesota Statutes 2019, Chapter 182;

5. DLI has authority to receive complaints about violations of paragraphs 1 through 4 and enforce these provisions using the procedures contained in Minnesota Statutes 2019, section 182.669, including awards of backpay and compensatory damages;

6. Pursuant to Minnesota Statutes 2019, section 268.095, any worker who quits their employment because the employer has failed to correct an adverse work condition related to the pandemic which would compel an average, reasonable worker to quit, if the worker has complained to the employer about such adverse work condition and has given the employer a reasonable opportunity to correct such adverse work condition, to no avail, or has been retaliatorily terminated from their employment as a result of exercising the worker rights described in paragraphs 1 through 4 of this concurrent resolution, shall not lose unemployment insurance benefits eligibility under existing law and Executive Order 20-05. Examples of an adverse work condition include an employer's failure to develop or implement a COVID-19 Preparedness Plan, as required by applicable Executive Orders, or failure to adequately implement Minnesota OSHA Standards or MDH and CDC Guidelines in the workplace related to COVID-19;

7. Pursuant to the MHRA, Minnesota Statutes 2019, Chapter 363A, and the existing authority of the Commissioner of Human Rights, the Commissioner of Human Rights is authorized to issue guidance, as necessary, consistent with federal and state anti-discrimination laws, including the MHRA, regarding employers' obligations to provide reasonable accommodations related to COVID-19 for qualified employees with disabilities, as defined in the MHRA, which may include employees

with health conditions who are at high-risk, as determined by relevant guidelines from the CDC or MDH, if they are exposed to or if they contract COVID-19;

8. Reasonable accommodations related to COVID-19 for such employees may include, but are not limited to, adjusting schedules or work stations, allowing employees to work from home, or permitting use of leave;

9. The rights and protections set forth in this concurrent resolution are available to all workers regardless of immigration status, and in addition to any other rights or protections established by any other law, rule, regulation, executive order, contract, or collective bargaining agreement; NOW, THEREFORE,"

The motion prevailed. So the amendment was adopted.

The question was taken on the adoption of the resolution, as amended.

INTRODUCTION AND FIRST READING OF SENATE BILLS

The following bills were read the first time.

Senators Limmer, Relph, Hall, Ingebrigtsen, and Johnson introduced--

S.F. No. 1: A bill for an act relating to public safety; modifying a past appropriation to the Peace Officer Standards and Training Board; amending Laws 2019, First Special Session chapter 5, article 1, section 13, subdivision 4.

Senator Gazelka moved that S.F. No. 1 be laid on the table. The motion prevailed.

Senators Anderson, P.; Pratt; Housley; Isaacson; and Tomassoni introduced--

S.F. No. 2: A bill for an act relating to economic development; appropriating money for emergency small business grants and loans; reimbursing the Minnesota 21st century minerals fund; adjusting the budget reserve forecast calculation; changing the fund receiving small business loan repayments; making technical changes; amending Minnesota Statutes 2018, section 16A.152, subdivision 2; Laws 2020, chapter 71, article 1, section 11.

Senator Gazelka moved that S.F. No. 2 be laid on the table. The motion prevailed.

Senator Ingebrigtsen introduced--

S.F. No. 3: A bill for an act relating to public safety; reporting law enforcement use of force; requiring reports; proposing coding for new law in Minnesota Statutes, chapter 626.

Senator Gazelka moved that S.F. No. 3 be laid on the table. The motion prevailed.

Senator Senjem introduced--

S.F. No. 4: A bill for an act relating to capital improvements; authorizing spending to acquire and better public land and buildings and other improvements of a capital nature with certain conditions; modifying previous appropriations; establishing new programs and modifying existing programs; authorizing the sale and issuance of state bonds; requiring a report; appropriating money; amending Minnesota Statutes 2018, sections 16B.325, subdivision 3; 137.61; 137.62, subdivision 2, by adding a subdivision; 137.63; 137.64; Laws 2014, chapter 294, article 1, section 7, subdivision 11, as amended; Laws 2017, First Special Session chapter 8, article 1, sections 15, subdivisions 3, as amended, 4; 18, subdivision 3; 20, subdivision 21, as amended; Laws 2018, chapter 214, article 1, sections 16, subdivision 19; 21, subdivisions 18, 26, 29; Laws 2019, First Special Session chapter 3, article 1, section 2, subdivisions 3, 5; proposing coding for new law in Minnesota Statutes, chapter 174.

Senator Gazelka moved that S.F. No. 4 be laid on the table. The motion prevailed.

Senator Ingebrigtsen introduced--

S.F. No. 5: A bill for an act relating to public safety; limiting admissibility of statements made during public safety peer support activity and critical incident stress management services; amending Minnesota Statutes 2018, section 181.973; proposing coding for new law in Minnesota Statutes, chapter 181.

Senator Gazelka moved that S.F. No. 5 be laid on the table. The motion prevailed.

Senator Westrom introduced--

S.F. No. 6: A bill for an act relating to telecommunications; establishing a funding program for distance learning equipment; establishing a grant program for telemedicine equipment purchased to deal with COVID-19; requiring reports; appropriating money.

Senator Gazelka moved that S.F. No. 6 be laid on the table. The motion prevailed.

Senator Nelson introduced--

S.F. No. 7: A bill for an act relating to education finance; appropriating money for Language Essentials for Teachers of Reading and Spelling grants.

Senator Gazelka moved that S.F. No. 7 be laid on the table. The motion prevailed.

Senator Chamberlain introduced--

S.F. No. 8: A bill for an act relating to taxation; modifying income and corporate franchise, special taxes, and property taxes; modifying the K-12 education expense credit, charitable contribution subtraction, and section 179 expensing provisions; providing ongoing funding for the small business investment tax credit; extending certain deadlines; modifying certain lawful gambling tax and other provisions; providing for certain federal conformity; modifying referendum equalization levy; requiring a moratorium on reclassifying certain property; amending Minnesota Statutes 2018, sections 273.13, subdivision 25; 290.0131, subdivision 10; 290.0133, subdivision 12; 290.0674, subdivision 2; 297E.02, subdivision 6, as amended; 297E.021, subdivision 2; 349.15, subdivision 1; 349.151, subdivision 4; Minnesota Statutes 2019 Supplement, sections 116J.8737, subdivision 5, as amended; 126C.17, subdivision 6; 289A.02, subdivision 7; 290.01, subdivisions 19, 31; 290.0132, subdivision 7; 290.0921, subdivision 2; 290A.03, subdivision 15; 291.005, subdivision 1; repealing Minnesota Statutes 2018, sections 290.0674, subdivision 2a; 290.0692, subdivision 6; Minnesota Statutes 2019 Supplement, section 116J.8737, subdivision 12.

Senator Gazelka moved that S.F. No. 8 be laid on the table. The motion prevailed.

Senators Abeler and Hoffman introduced--

S.F. No. 9: A bill for an act relating to human services; modifying provisions relating to child care, foster care, disability services, community supports, civil commitment, maltreatment of minors, child protection, and child support; expanding definition of providers for child care assistance program; requiring students in foster care who change schools to be enrolled within seven days; requiring responsible social services agencies to initiate and facilitate phone calls between parents and foster care providers for children in out-of-home placement; requiring responsible social services agencies to coordinate prenatal alcohol exposure screenings for children in foster care; directing the commissioner of human services to modify a report and develop training; modifying provisions relating to child care services grants; clarifying commissioner authority to waive child care assistance program provider requirements during declared disaster; modifying family day care training requirements; requiring local agencies to use a universal form to process family day care variance requests and post variance policies publicly; modifying background study requirements for guardians and conservators; modifying the definition of supervision in child care center settings; extending sunset for Cultural and Ethnic Communities Leadership Council; extending the corporate adult foster care moratorium exception for a fifth bed until 2020; modifying timelines for intensive support service planning; permitting delegation of competency evaluations of direct support staff; modifying the training requirements for direct support staff providing licensed home and community-based services; codifying an existing grant program for fetal alcohol disorder prevention activities; codifying existing consumer-directed community supports laws; clarifying the excess income standard for medical assistance; extending end date for first three years of life demonstration project; permitting certain advanced practice registered nurses and physician assistants to order home health services
