In his current capacity as COO, Keith is responsible for the executive management of all facets of operations in construction and fabrication.

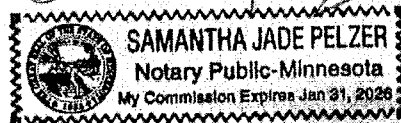


