Re: Application for re-appointment to Board of Trustees of Minnesota State Colleges and Universities

Dear Governor Walz and Lt. Governor Flanagan:

I am writing to let you know that I will apply for re-appointment to the Board of Trustees of Minnesota State Colleges and Universities. I provide the following information as you consider my application.

Governor Dayton appointed me to the Board in February 2017; I served one year of the unexpired term of Margaret Anderson Kelliher, who resigned from the Board. Governor Dayton appointed me to a full term in July 2018.

I have appreciated the opportunity to serve on the Board the last seven years and have been an active member since my appointment. I currently serve as Vice-Chair of the Board of Trustees and Chair of the Diversity, Equity, and Inclusion Committee and the Workforce and Organizational Effectiveness Committee. I have also chaired the Audit Committee, and in 2023, I was Co-Chair of the Chancellor Search Committee.

After the murder of George Floyd and civil unrest in the Twin Cities, Minnesota State convened a Taskforce on Law Enforcement Education Reform. The Task Force consisted of 36 diverse Minnesota State and community members. I served as Co-Convener, along with Minnesota Commissioner of Higher Education Dennis Olson and Senior Vice Chancellor Satasha Green-Stephen. Our Task Force examined and advised on issues, initiatives, programming, and priorities relative to an anti-racist law enforcement education. We issued our report in February 2021 and have worked with stakeholders to implement its recommendations.

I am a member of the White Earth Band of Ojibwe; my mother grew up on the Reservation. I serve as a Justice on the White Earth Tribal Court of Appeals, and I travel to the Reservation often to hear appeals. I also serve as a Court of Appeals Judge for four other Minnesota Tribes: Leech Lake Band of Ojibwe, Fond du Lac Band of Lake Superior Chippewa, Prairie Island Indian Community, and Lower Sioux Indian Community. I have been active in the Minnesota American Indian Bar Association since the early 1990s and served as its President in 2004-2006. I was a Member of the Board of the Division of Indian Work in Minneapolis from 2014-2023, was Board Chair in 2019-2020, and continue to be an involved participant and supporter of DIW.

As a proud alumnus of Minnesota State University Moorhead, I am active in supporting the University and its students. I served for several years as a member of the Foundation Board. My wife and I started and financially support a scholarship program for American Indian students at MSUM (and the American Indian Center there bears my name).

I am by training and experience a trial lawyer. I am a founding partner of a Twin Cities civil litigation law firm and have practiced in Minnesota since graduating from Harvard Law School in 1979. I have tried over 60 civil cases in 19 states, managed litigation nationwide for clients, worked as managing partner of law firms, and served as a mentor to law students and young lawyers and as an advocate for diversity in the profession and judiciary.

Serving the community has been one of my passions my entire career. I have held several Minnesota leadership positions and served on non-profit boards. Most notably, I served on the Minnesota Commission on Judicial Selection for 11 years, including as Commission Chair under Governor Ventura. I also chaired the Civil Litigation Section of the Minnesota State Bar Association, the Minnesota Chapter of the American Board of Trial Advocates, and the Hennepin County Sheriff Foundation.

If re-appointed, I would continue to work to put students first in our stewardship of state colleges and universities. I strongly support the System's Equity 2030 goal to close educational equity gaps at every Minnesota State college and university. We also have much work ahead to develop the System's NextGen technology program and to continue to make higher education available and affordable to all Minnesotans. I would like students to have the same opportunities that I had because of my state university education.

Thank you for considering my application for re-appointment to this important position.
