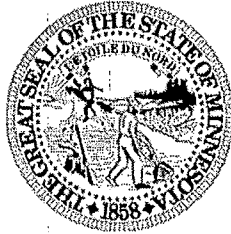

I am writing to seek reappointment to the Board of Trustees of the Minnesota State Colleges and Universities System. I was first appointed to the board by Governor Mark Dayton on August 24, 2016, with my term ending June 30, 2022. I live in and represent the 6<sup>th</sup> Congressional District. In the last six years I transitioned from neophyte board member to a confident representative of Minnesota State's mission and interests. As my resume details, I was employed as a full-time faculty member in the MN State system for twenty-five years. Mere weeks after retiring my position in 2016, I was contacted by Governor Mark Dayton's office.

During this term, my efforts and energy reached beyond the board room. I have been part of search teams interviewing candidates for at least nine high level positions including presidents, vice chancellors and the chancellor search.

Additionally, my work with the Academic and Student Affairs Committee (ASA) is noteworthy. In the last two years I have served as committee chair. Throughout my term I actively promoted the work of ASA by attending system conferences, scholarship and fundraising events, Senate Higher Ed committee hearings and more. As Committee Chair I have represented the board in at least six Higher Learning Commission Accreditation and site visits.

My participation speaks broadly of my passion and commitment to the interests of Minnesota State. Through two pandemic years and the illness, home hospice and death of my husband in 2019, I have a nearly spotless record for attendance at meetings. I have attended national conferences, professional board training sessions and an array of campus events including graduation and nursing pinning ceremonies across the state.
