FIRST READING OF HOUSE BILLS

The following bills were read the first time.

H.F. No. 124: A bill for an act relating to public safety; allowing for the acceptance of certain gifts related to a line of duty death of a public safety officer; authorizing local government expenditure for public safety officer killed in the line of duty; amending Minnesota Statutes 2024, section 471.198; proposing coding for new law in Minnesota Statutes, chapter 299A.

Referred to the Committee on Judiciary and Public Safety.

H.F. No. 129: A bill for an act relating to public safety; requiring director of child sex trafficking prevention to submit a program evaluation each odd-numbered year to the legislature; amending Minnesota Statutes 2024, section 145.4718.

Referred to the Committee on Judiciary and Public Safety.

H.F. No. 286: A bill for an act relating to public safety; authorizing local units of government to conduct criminal background checks under certain circumstances; proposing coding for new law in Minnesota Statutes, chapter 299C.

Referred to the Committee on Judiciary and Public Safety.

REPORTS OF COMMITTEES

Senator Murphy moved that the Committee Reports at the Desk be now adopted. The motion prevailed.

Senator Wiklund from the Committee on Health and Human Services, to which was referred

S.F. No. 2043: A bill for an act relating to health occupations; establishing a spoken language health care interpreter work group; requiring reports; appropriating money; proposing coding for new law in Minnesota Statutes, chapter 144.

Reports the same back with the recommendation that the bill be amended as follows:

Page 3, after line 14, insert:

"Subd. 4. **Compensation.** Compensation shall be offered to work group members not being compensated for their participation in work group activities as part of their existing job duties. Work group members shall be compensated for work group activities under section 15.059, subdivision 3."

And when so amended the bill do pass and be re-referred to the Committee on State and Local Government. Amendments adopted. Report adopted.

Senator Wiklund from the Committee on Health and Human Services, to which was referred

S.F. No. 1567: A bill for an act relating to health; establishing an office of patient protection; establishing responsibilities of an office of patient protection; requiring reports; proposing coding for new law in Minnesota Statutes, chapter 62J.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on Commerce and Consumer Protection. Report adopted.

Senator Putnam from the Committee on Agriculture, Veterans, Broadband, and Rural Development, to which was referred

S.F. No. 1575: A bill for an act relating to agriculture; establishing the biofertilizer water preservation program; requiring rulemaking; appropriating money; amending Minnesota Statutes 2024, section 18C.005, by adding a subdivision; proposing coding for new law in Minnesota Statutes, chapter 18C.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. **BIOFERTILIZER WATER PRESERVATION PROGRAM.**

Subdivision 1. **Definitions.** For the purposes of this section, "commercial nitrogen fertilizer" means a fertilizer with a nitrogen content of no less than 25 percent.

Subd. 2. **Program established.** In consultation with the commissioner of natural resources and soil and water conservation districts in Minnesota, the commissioner of agriculture must develop and administer a biofertilizer water preservation pilot program to address water quality by incentivizing Minnesota farmers to improve nitrogen management and incorporate innovative technologies into the farmers' crop nutrient management plans. The commissioner must determine which products qualify for the program, including soil amendments, fertilizers with nitrogen fixing properties, biological sources of nitrogen, and other biofertilizers.

Subd. 3. **Payments to qualified farmers.** (a) In consultation with farmers and the fertilizer industry, the commissioner may establish a per acre payment rate, not less than \$5 per acre, for payments provided to a qualifying farmer. The program may provide an annual per acre incentive payment to a qualifying farmer who verifies through documentation that the farmer has reduced commercial nitrogen fertilizer rates by using a qualifying product in the farmer's crop nutrient management plans by the lesser of:

(1) 15 percent; or

(2) 30 pounds per acre.

(b) The Department of Agriculture must annually review and may adjust the per acre payment rate based on inflation and emerging fertilizer technology.

Subd. 4. **Qualifications.** To qualify for the biofertilizer water preservation program, a farmer must:

(1) be a farmer in the state; and

(2) submit documentation to the commissioner, including a crop nutrient management plan that will reduce the use of commercial nitrogen fertilizers at the reduction rate required under subdivision 2 by using a qualifying product determined by the commissioner under subdivision 1.

Subd. 5. **Report required.** (a) By January 8, 2028, the commissioner must report on the program, including the following information:

(1) the program's required minimum commercial nitrogen fertilizer reduction rate under subdivision 3 and whether an increase in the minimum reduction rate is necessary;

(2) additional qualifying products that may be used by farmers in the program. When making this determination, the commissioner must consider newly available technologies and products capable of reducing commercial nitrogen fertilizer applications;

(3) the use of program funds, including the incentive payment rate made to farmers;

(4) the number of farmers and the number of acres in each county that receive an incentive payment; and

(5) an estimate of the amount of commercial nitrogen fertilizer reduced due to the program.

(b) The commissioner must submit the report to the chairs and ranking minority members of the legislative committees with jurisdiction over agriculture policy and finance.

Subd. 6. **Data privacy.** Any documentation submitted by a farmer to qualify for the program under subdivision 4 is classified as nonpublic data, as defined in Minnesota Statutes, section 13.02, subdivision 9, or private data on individuals, as defined in Minnesota Statutes, section 13.02, subdivision 12, but the data may be used to complete the report under subdivision 5, provided that the identity of a particular grantee must not be revealed or made ascertainable in the report.

Sec. 2. **APPROPRIATION.**

\$5,000,000 in fiscal year 2026 is appropriated from the general fund to the commissioner of agriculture to establish and administer the biofertilizer water preservation program. Notwithstanding Minnesota Statutes, section 16A.28, any unencumbered balance at the end of fiscal year 2026 does not cancel and is available in fiscal year 2027. "

Delete the title and insert:

"A bill for an act relating to agriculture; establishing the biofertilizer water preservation pilot program; requiring a report; appropriating money."

And when so amended the bill do pass and be re-referred to the Committee on Judiciary and Public Safety. Amendments adopted. Report adopted.

Senator Putnam from the Committee on Agriculture, Veterans, Broadband, and Rural Development, to which was referred

S.F. No. 1840: A bill for an act relating to agriculture; establishing a grant program to promote certain nutrient management practices; appropriating money; proposing coding for new law in Minnesota Statutes, chapter 17.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 7, delete everything after "must" and insert "establish a grant program"

S.F. No. 1842: A bill for an act relating to education; modifying teacher licensure requirements; requiring professional development on dyslexia; requiring rulemaking; amending Minnesota Statutes 2024, sections 122A.181, subdivision 3; 122A.182, subdivision 3; 122A.187, by adding a subdivision.

Reports the same back with the recommendation that the bill do pass and be re-referred to the Committee on State and Local Government. Report adopted.

Senator Hoffman from the Committee on Human Services, to which was referred

The base for this appropriation is \$17,268,000 in fiscal year 2026 and \$17,280,000 in fiscal year 2027.

Council on Developmental Disabilities. \$222,000 each year is for the Council on Developmental Disabilities.

State Agency Accommodation Reimbursement. \$200,000 each year may be transferred to the accommodation account established in Minnesota Statutes, section 16B.4805.

Disparity Study. \$500,000 the first year and \$1,000,000 the second year are to conduct a study on disparities in state procurement. This is a onetime appropriation.

Grants Administration Oversight. \$2,411,000 the first year and \$1,782,000 the second year are for grants administration oversight. The base for this appropriation in fiscal year 2026 and each year thereafter is \$1,581,000.

\$735,000 the first year and \$201,000 the second year are for a study to develop a road map on the need for an enterprise grants management system and to implement the

study's recommendation. This is a onetime appropriation.

Risk Management Fund Property Self-Insurance. \$12,500,000 the first year is for transfer to the risk management fund under Minnesota Statutes, section 16B.85. This is a onetime appropriation.

Office of Enterprise Translations. \$1,306,000 the first year and \$1,159,000 the second year are to establish the Office of Enterprise Translations. \$250,000 each year may be transferred to the language access service account established in Minnesota Statutes, section 16B.373.

Capitol Mall Design Framework Implementation. \$5,000,000 the first year is to implement the updated Capitol Mall Design Framework, prioritizing the framework plans identified in article 2, section 124. This appropriation is available until ~~December 31, 2024~~ June 30, 2026.

Parking Fund. \$3,255,000 the first year and \$1,085,000 the second year are for a transfer to the state parking account to maintain the operations of the parking and transit program on the Capitol complex. These are onetime transfers.

Procurement; Environmental Analysis and Task Force. \$522,000 the first year and \$367,000 the second year are to implement the provisions of Minnesota Statutes, section 16B.312.

Center for Rural Policy and Development. \$100,000 the first year is for a grant to the Center for Rural Policy and Development.

EFFECTIVE DATE. This section is effective retroactively from July 1, 2024."

Delete the title and insert:

"A bill for an act relating to state government; extending the availability of an appropriation for implementing the Capitol Mall Design Framework; amending Laws 2023, chapter 62, article 1, section 11, subdivision 2."

EFFECTIVE DATE. This section is effective January 1, 2026, or upon federal approval, whichever is later. The commissioner of human services shall notify the revisor of statutes when federal approval is obtained.

- (4) fins, mask, and snorkel;
- (5) a compressed gas cylinder and valve;
- (6) a primary regulator and alternate air source;
- (7) a breathing-gas monitoring device;
- (8) a quick-release weight system and weights;
- (9) adequate exposure protection appropriate for local dive conditions;
- (10) at least one audible emergency surface-signaling device; and
- (11) a dive computer or recreational dive planner (RDP).

Subd. 4. **Standby diver required.** An employer must ensure that a standby diver is available while a diver is in the water. No employer may allow an individual to act as a standby diver unless that individual has a valid rescue diver certificate received from a nationally recognized and accredited certification program. An extra breathing gas hose capable of supplying breathing gas to the diver in the water must be available to the standby diver.

Subd. 5. **First aid and CPR training required.** An employer shall require that all individuals subject to this section conducting scuba diving are trained in cardiopulmonary resuscitation (CPR) and first aid, the American Red Cross standard course or equivalent.

Subd. 6. **Penalties.** An employer may be cited by the commissioner for violations of subdivisions 2 to 5. Citations are punishable under section 182.666.

Subd. 7. **Information for employers.** The commissioner must develop an information sheet for employers who have or intend to have one or more employees use scuba diving equipment in the workplace. The information sheet must explain the requirements of this section and include any applicable federal requirements for employers. The commissioner must post the information sheet on the department's website. The commissioner must also deliver the information sheet to the commissioner of natural resources to provide to businesses according to section 103G.615, subdivision 1, paragraph (e).

EFFECTIVE DATE. This section is effective May 1, 2025."
